Terms: The Owner is responsible for obtaining any necessary health certificates and for informing All American Alpacas of any unusual health conditions.

Each alpaca must have a health certificate within 30 days of destination date, meeting the requirements of the destination state, and proof of negative BVD by PCR. All animals must be microchipped.

Waiver of Liability: During the time the alpacas are in the care and custody of transporter, transporter shall not be liable for any sickness, disease, stray, theft, death or other injury which may be suffered by the alpacas or for any other cause of action arising out of the contract.

Owner To Insure, or Self-Insure: owners represent either that the alpacas are insured with a "full mortality" insurance policy or that the owners are acting as their own self-insurer, both as to mortality, and also as to any injury, damage or any event causing a loss of value of alpacas that may occur. Owners further agree that their sole remedy, in the event of damage, loss or any event causing a loss of value to either dam or any cria at their side, shall be to make claim against any insurance policy that they have acquired. If owners fail to acquire such insurance and hence act as their own self-insurer, they shall be deemed to have waived any claim against transporter both as to mortality, and also as to any injury, damage or any event causing a loss of value of alpacas that may occur.

Hold Harmless: owners agree to hold transporter harmless from any claim resulting from damage or injury caused by the alpacas to anyone and agree to pay any attorney's fees, costs, or expenses incurred in defense of such claims.

Authorization of Emergency Care: owners authorize emergency veterinary care and agree to pay all necessary and reasonable veterinary charges for services rendered to the alpacas while in the care of transporter.

A deposit of 50% is due upon the signing of this agreement. Due to expenses involved in cancellations, this deposit is refundable only if the All American Alpacas is unable to make the trip as scheduled. Client is responsible for all medical bills, health certificates, non-routine expenses, and insurance. In the event that the required paperwork is not available or alpacas are not ready to be transported when the transporter arrives to pick up the animals, the animals will not be transported and the deposit will not be refunded.
